My comments for your Consideration

Some retirees, like me, were left out of the Butch Lewis Emergency Pension Plan Relief Act because our pensions cuts were under bargaining agreements, such as YRC (Yellow Frieght). PBGC received millions in funding under the Trump administration. Our pensions could be fully reinstated through PBGC with funds already contributed to it plus through increased multiemployer plan premiums. In order to treat all retirees the same, our back pay should be refunded as will be done for retirees with cuts under MPRA.

I retired on September 28th,2010 because I became disabled. CSPF notified me that they were going to cut pensions starting September 24th,2010 and if CSPF would have told me that date of the 24th I would have retired before the 24th. Doctors told me my injury was life altering and that I was done working. I didn't have the luxury of going back to work being disabled. I lost 56% of my 37 year pension. I don't know whose fault it is for the multiemployer pensions to get in bad shape and I'm the last person to point fingers but I do know I was told in 1973 when I started for ROADWAY EXPRESS work hard do your job and get paid good, good benefits and a great pension. I worked hard for 37 years like everybody else and earned my full pension . I just don't understand what I did wrong and what other retirees that didn't cut did right. I was at a save our pension meeting one time and I got up and told everybody to fight to keep their pensions and don't let what happened to me happen to them. My wife and I have suffered severely over the last 11 years and were raising two grandchildren. I know two people in my neighborhood that I worked with at roadway and they are celebrating that they get to keep their full pensions and enjoy there golden years of retirement. On August 23rd my wife and I will celebrate our 52nd wedding anniversary and for the last 11 years we haven't celebrated much because of my pension and my wife asked me if we were going to be able to do anything this year, I didn't know what to say. All I want is to

enjoy my golden years with my family with a full pension and back pay that I worked hard for and earned like all other retirees. Please Please PBGC would you consider helping me on my pension . Thank You
