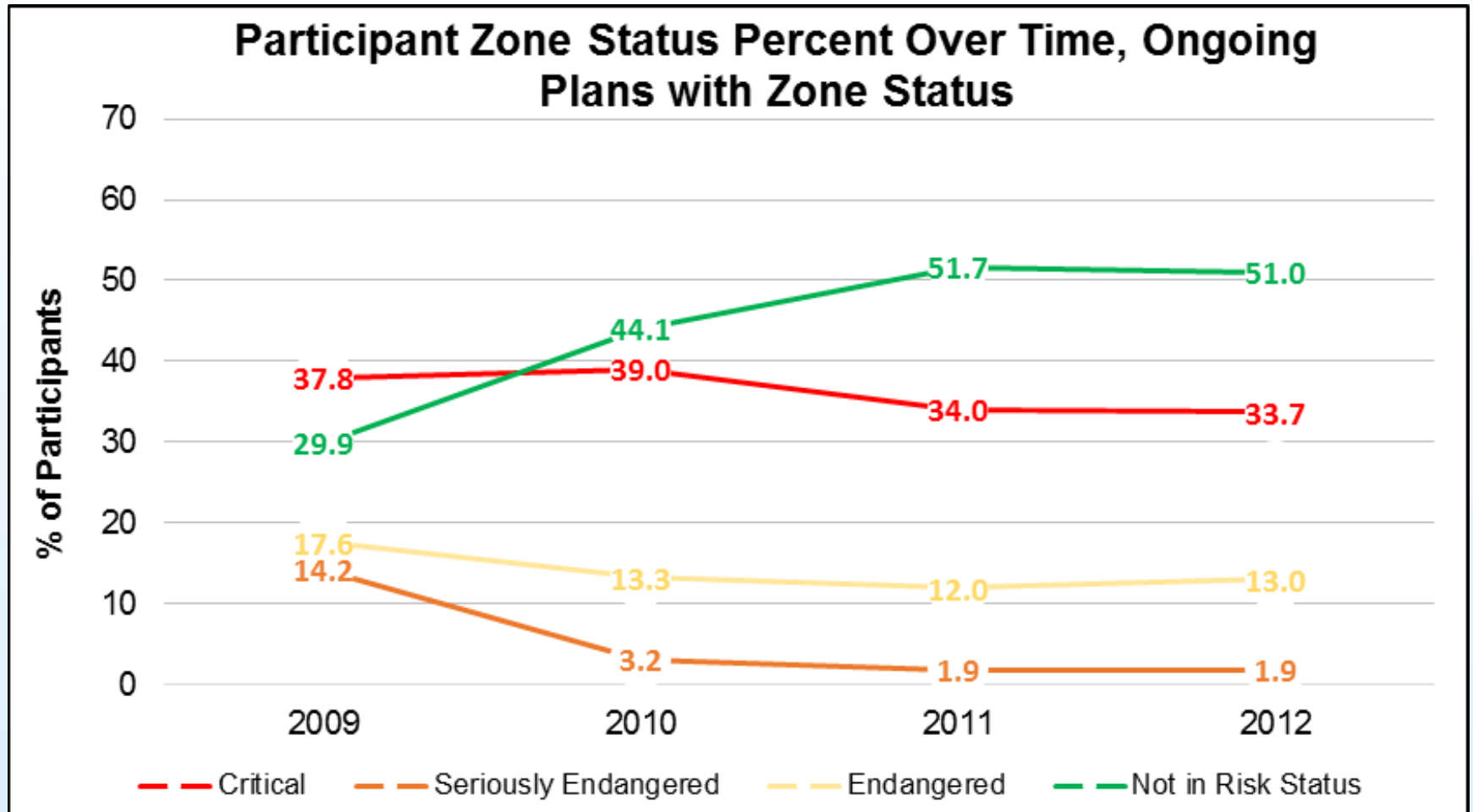




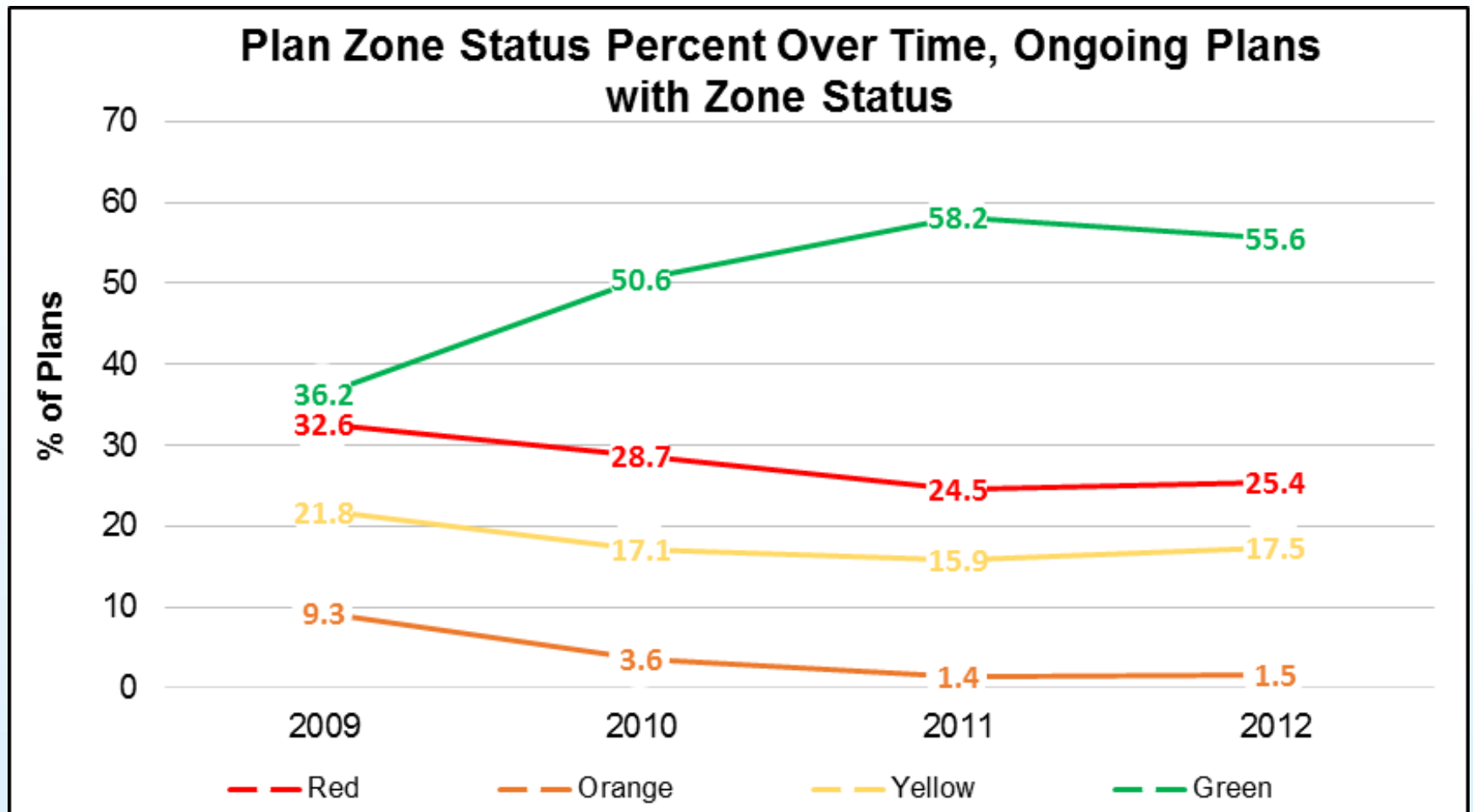

Zone Status over Time (Participant)



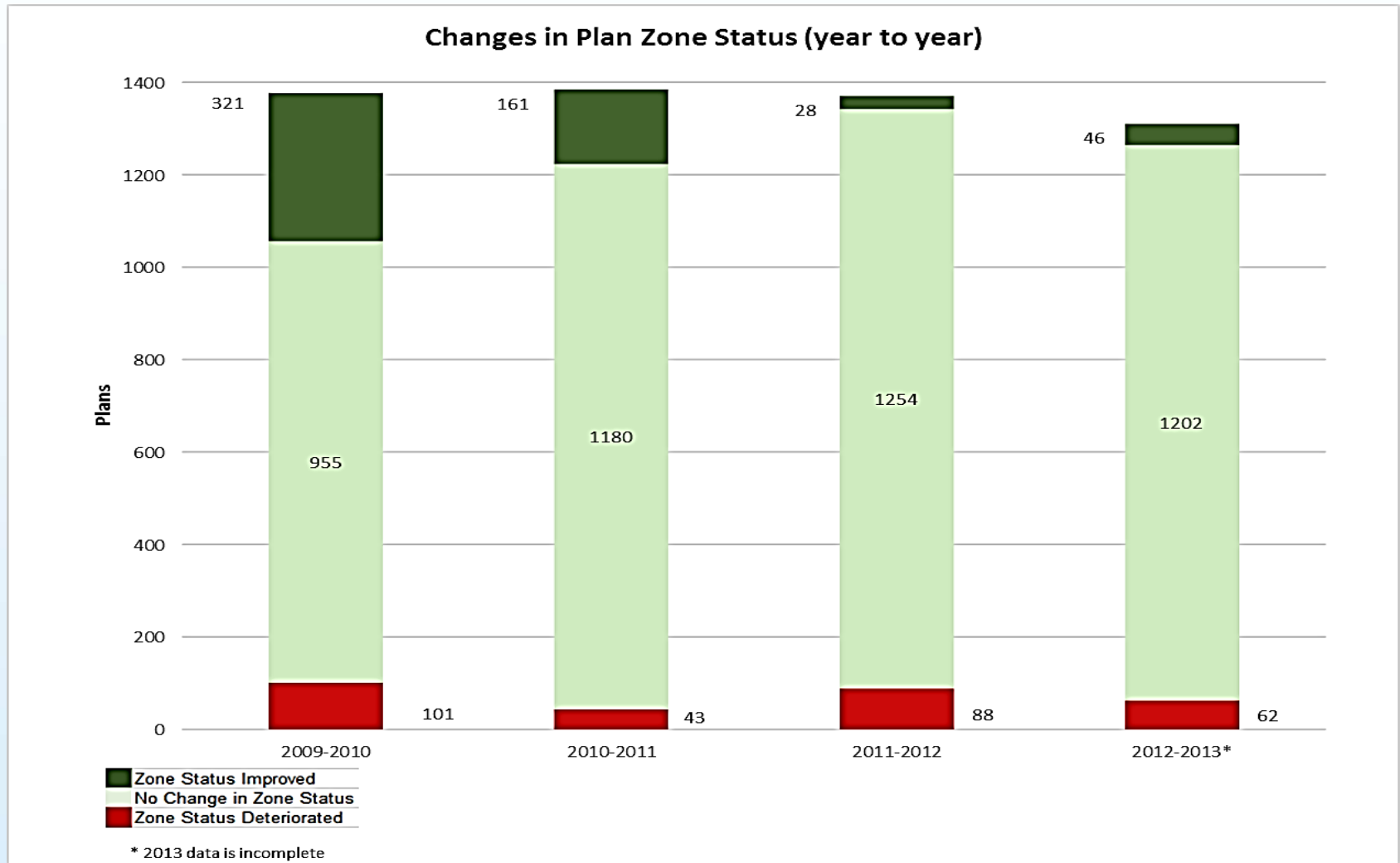

Zone Status over Time (Plans)

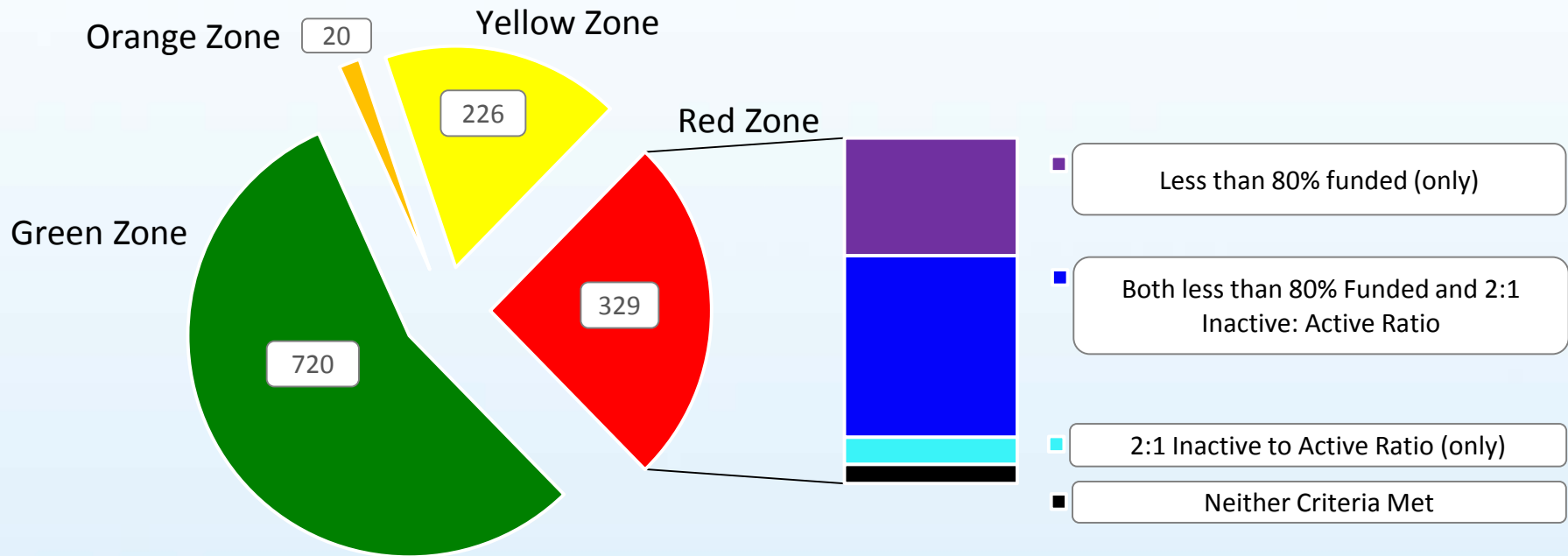

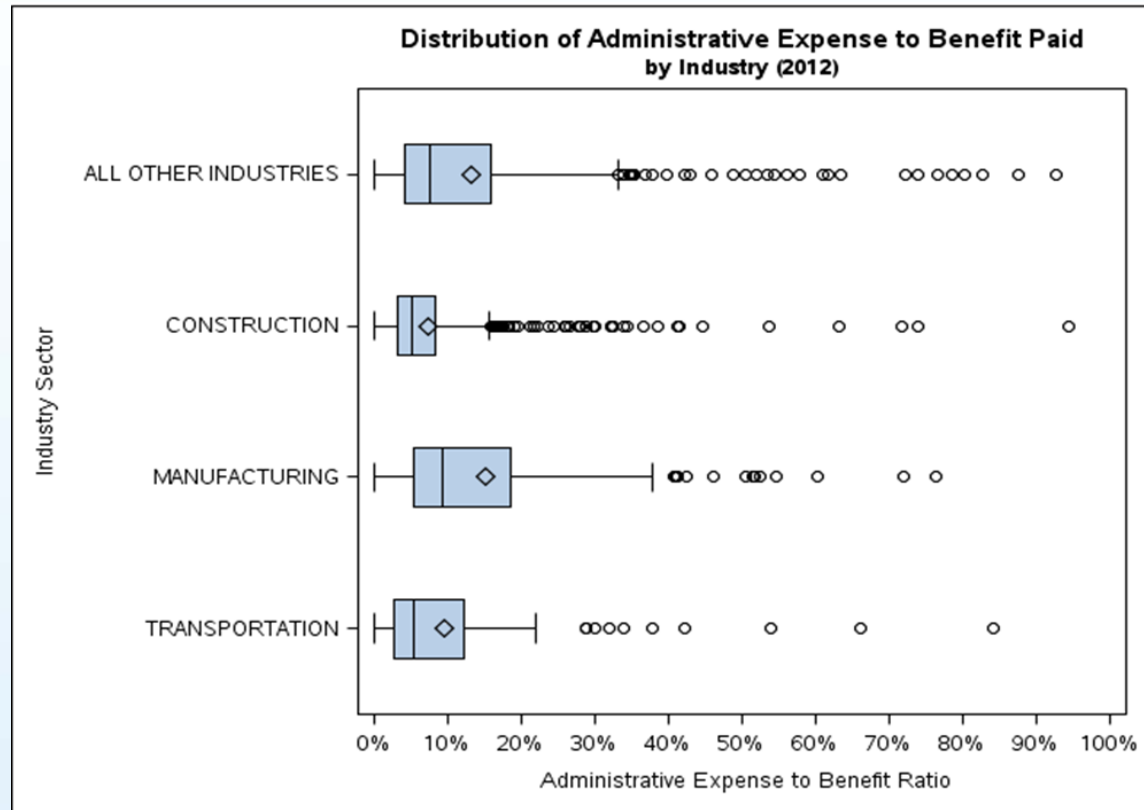
Direction of Zone Status Changes



Zone Status and Tests for Declining Status

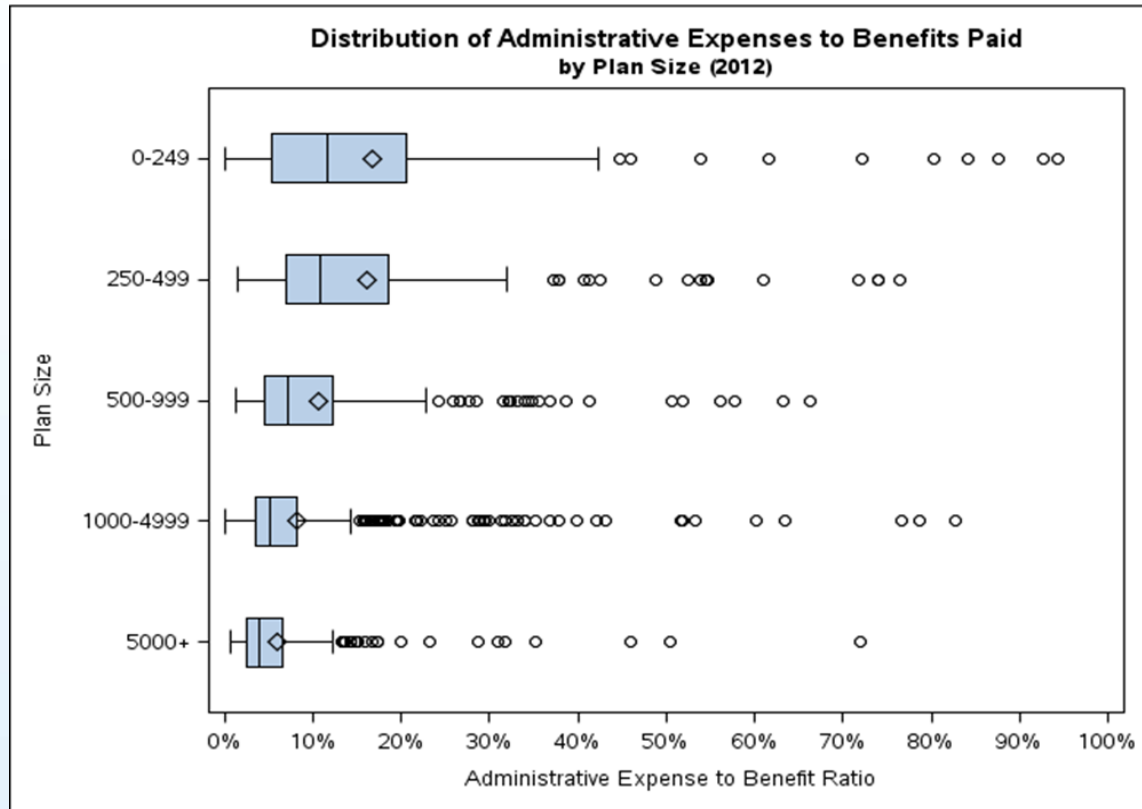
