Pension Benefit Guaranty Corporation Federal Employee Viewpoint Survey and Trend Report for 2015¹

We Seek Employees' Perspectives

To find out how PBGC employees feel about working here, we ask them to take the Federal Employee Viewpoint Survey. We use their responses to measure employee engagement and satisfaction.

An Engaged Workforce

We ranked 10th among 37 large federal agencies in the Employee Engagement Index. This index is composed of three sub-factors: Leaders Lead, Supervisors, and Intrinsic Work Experience. The index provides a guide to the critical areas that agencies can focus on to foster an engaged workforce. Our employees responded positively to the questions in this index. Those questions receiving high scores included:

- I know how my work relates to the agency's goals and priorities (89%)
- I know what is expected of me on the job (81%)
- My supervisor listens to what I have to say (80%)

PBGC employees are very satisfied with our Work/Life Programs, giving high scores for Alternate Work Schedules, Health and Wellness and Telework.

A Satisfying Work Experience

Employees gave high marks when asked about their PBGC work experience. Their responses showed that they understand the importance of our mission to protect the retirement incomes of about 41 million American workers and retirees in nearly 24,000 defined benefit pension plans.² Those questions receiving the highest marks are as follows:

- When needed, employees are willing to put in the extra effort to get a job done (96%)
- Employees believe the work they do is important (92%)
- Employees are constantly looking for ways to do their job better (90%)

Communicate, Respect, Balance

Employees also expressed satisfaction with the relationship they have with their immediate supervisors. Their feedback showed that they believe their supervisors:

- Communicate with them about their performance (85%)
- Provide the support needed to balance work and other life issues (85%)
- My supervisor treats me with respect (84%)

A Commitment to Improve

At PBGC, we recognize the importance of offering employees the chance to grow using their unique talents and strengths to do work that matters. While some scores have improved over the last year, others have declined. The 2015 FedView results will help us strive toward a model work environment that supports effective human capital practices.³

For example, *Positive* represents responses of Strongly Agree and Agree and Very Satisfied and Satisfied. *Neutral* represents responses of Neither Agree nor Disagree and Neither Satisfied nor Dissatisfied; *Negative* represents responses of Disagree and Strongly Disagree and Dissatisfied and Very Dissatisfied.
